SPILL CLEAN UP METHODS

Stop leak if possible without risk. Extinguish all ignition sources. Avoid sparks, flames, heat and smoking. Ventilate. Flush with plenty of water to clean spillage area.

7 HANDLING AND STORAGE**USAGE PRECAUTIONS**

Avoid spilling, skin and eye contact. Keep away from heat, sparks and open flame. Avoid eating, drinking and smoking when using the product. Ventilate well, avoid breathing vapours. Use approved respirator if air contamination is above accepted level. Container must be kept tightly closed.

STORAGE PRECAUTIONS
